

Terms and Conditions of Win a Fiat 500S:

1. This promotion (Prize Draw) is open to entrants aged 18 and over who are retail customers of Fiat, Abarth and Fiat Professional but excludes employees and their immediate families of Fiat Chrysler Automobiles N.V. companies, and their agents or anyone professionally connected with this Prize Draw.
